- b) That you shall be entitled to debit my/our account or accounts at any of your offices or branches without any notice to me/us or any of us even to the extent of creating any new or increasing any existing overdraft or liability on any of my/our account or accounts with the amount of any payments that you may make under or purporting to be made under or in respect of the said Letter of Guarantee/Security Bond regardless of the fact that as a result of or in consequence thereof any cheques orders for payment of money or withdrawal applications drawn or made by me/us or any of us upon you may be returned or dishonored or refused payment by you for want of sufficient funds and you shall not however be hereby obliged to create or increase any overdraft or liability on any of my/our accounts.

- d) That any and every request made upon you for payment of any sum of or sums of money shall be a sufficient authority to you for making any such payment or payments and you shall not under any circumstances be concerned to enquire whether the amount of any such payment is or are in fact or in law due under the said Letter of Guarantee/Security Bond or otherwise and that your decision to make such payment or payments shall be finally binding and as between me/us and you and I/we shall not be entitled to question on any ground whatsoever such payment or payments under any rule of law or equity notwithstanding anything contrary herein contained.
