

LETTER OF INDEMNITY TO COVER ELECTRONIC- MAIL (E- Mail) TRANSMISSIONS

I/We hereby request you to accept instructions transmitted by way of Electronic – Mail (E-Mail) in respect of the operations of my/our current/savings account/s no _____ for effecting following transactions without having the original documents containing such Electronically Mailed (E-Mailed) instructions in confirmation thereof.

- Enrolling for Internet Banking and other Value Added services

I/We understand the inherent problems in verifying the source of Electronic – Mail (E-Mail) transmissions and authenticity signatures on Electronically Mailed (E-Mailed) documents and confirm that you shall only be obliged to compare the signatures shown on the Electronic – Mail (E- Mail) transmissions with the signature(s) in your record as far as practicable in the circumstances and shall not hold you responsible for any unauthorized use of my/our signature(s) on the Electronic – Mail (E-Mail) transmissions.

Further you shall be entitled to act on such Electronic – Mail (E-Mail) transmissions without waiting for a confirmation by letter and even if such confirmation letter will not have been received by you or even if the purported confirmation letter shall contain instructions different to those mentioned in the Electronically Mailed (E-Mailed) instructions.

In consideration of your agreeing to accept and act at my/our request as aforesaid on notices and instructions sent by means of Electronic Mail (E-Mail) transmissions in respect of the aforesaid matters financial transactions and banking facilities I/We jointly and/or severally hereby undertake to indemnify you from acting in accordance with such instructions given in the Electronic Mail (E- Mail) transmissions bearing my/our signature(s) or our authorized signatories (as informed to you from time to time) and agree to hold you safe and harmless against any claims, damages, cost or any other rights or claims arising out of or in connection with the said transactions or account operations or any other related matter/s, disputes, legal proceedings or of whatsoever nature which you may incur in consequence of acting upon such Electronic Mail (E- Mail) transmissions without having first received the written original documents containing such Electronically mailed (E- Mailed) instructions in confirmation thereof. I/We further indemnify Amana Bank PLC for accepting a scanned copy of the original of this letter of Indemnity signed and accepted by me via email from my registered email account to continue the transactions with email instructions in respect of my existing Accounts with the Amana Bank PLC.
